

## The obligations of the provider

- The amount of the tourist tax must be displayed in the accommodation and must appear on the invoice issued.
- Register the number of guests, the amount of the occupancy rates. (Article of law R2333-34)
- Declare the tourist tax collected regularly.

Some accommodation booking web sites collect the tax instead of the owner. (Booking, Airbnb ...)

## How to declare

With the free online tourist tax site for hosts (hotels, residences, owners of furnished property, ...)

The website simplifies declaration. Bookings can be declared as soon as they are completed. It also allows to calculate the amounts to be paid, view the history of declarations, download summaries, update personal data, communicate with the tourist tax officer, print your receipt, and have access to useful documents (guest register, Cerfa forms ...)

## The tourist tax

### What is it ?

This tax is to be paid by clients at check-out in a hotel, in a campsite, etc. The tourist tax is dedicated to the financing of tourist promotion activities conducted by the Tourist Office.

It is collected by the host which gives it to the Public treasure once a year. The rates of the tourist tax are fixed by deliberation of the Grand Auch cœur de Gascogne community council, respecting the regulatory framework imposed by the rectifying finance law of December 28, 2017 (article 44 of LAW n ° 2017-1775 of December 28, 2017) for each type of accommodation and according to the classification, per person and per overnight stay.

### Who pays

The tourist tax applies to any person who is housed for a fee and who is not domiciled in the municipality and does not have a residence in the municipality where he is liable to the tax.

It is not generally included in the reservation quote but is announced in the terms.

### Exempt from paying the tax

- Under 18s,
- Those with a 'contrat saisonnier' employed within the Grand Auch cœur de Gascogne area,
- Those in emergency shelter or a temporary relocation.

## The amount of the tourist tax

## Calculation

Price according to the category of lodging (table below) : 2 adults and 2 children staying 1 night in a furnished accommodation 1 star (0.75€) :

$$\begin{aligned} \text{adults (2 x 1 night)} &\times 0.75 \text{ €} = 1.50 \text{ €} \\ \text{children (2 x 1 nuit)} &\times 0 \text{ €} = 0 \text{ €} \\ \text{Total rates} &: 1.50 \text{ €} \end{aligned}$$

Concerning the accommodation awaiting classification or without classification (tariff cap 2.50€) :

2 adults and 2 children staying in a furnished accommodation 150 € for 3 nights :

$$\begin{aligned} 150 / 3 \text{ nights} &= 50 \text{ € / night for the family} \\ 50 \text{ € / 4 pers} &= 12.50 \text{ € the cost of the night per person} \\ 4\% \text{ of } 12.50 \text{ €} &= 0.5 \text{ € per night and per person} \end{aligned}$$

The collected tax will be :


$$\begin{aligned} 2 \text{ adults} &: 2 \times 0.5 \text{ €} = 1.00 \text{ € per night} \\ 2 \text{ children} &: 2 \times 0 \text{ €} = 0 \text{ €} \end{aligned}$$

## To rank an accommodation

The ranking of an accommodation makes it possible to obtain from 1 to 5 stars. Not compulsory, it is assigned at the request of the landlord who will have to call on an organization approved to make the control visits to obtain the stars. The ranking allows homeowners to benefit from a tax exemption. Information: [www.atout-france.fr](http://www.atout-france.fr).

 If your accommodation has a label (Gîte de France, Clévacances, ...), only the prefectural ranking (number of stars) counts. Equivalencies are not allowed between the level of the label and the stars.
